Learners Code of Conduct:

Important

This document outlines general learner expectations of behavior in order to foster a positive, constructive, and safe learning environment at Gems Field Private School. It should be noted that the learner's self control of their behaviour constitutes an important segment of overall education and thus Gems Field Private School considers the code of conduct as a necessary skill for learners to attain for the benefit of their future integration into society."

List of offences:

- 1. **Schedule 1** Minor classroom infractions including, but not limited, to the following:
 - a. Eating, drinking, and chewing in class.
 - b. Using profane, vulgar language or obscene gestures.
 - c. Violating the dress code or grooming policy of the school.
 - d. Failing to comply with lawful directives issued by school personnel or school policies.
 - e. Arriving late for class.
 - f. Bringing cell phones or other distractions into class or to school.
 - g. Talking excessively in class or during assemblies.
 - h. Bringing the name of the school into disrepute.

2. Schedule 2 - More serious offences

- Repeated violation of Schedule 1 offences.
- b. NB REFUSAL to and or NOT completing assignments and or not copying class work as directed by the teacher.
- c. Refusal to participate in classroom activities.
- d. Failure to bring appropriate material to the classroom.
- e. Homework not completed.
- f. Cheating or copying other learner's work in class.
- g. Not cooperative in and disrupting classes.
- h. Abusive, aggressive, or disrespectful behaviour to teacher or other learners.
- i. Forgery (copying a teacher or parent's signature, for example).
- j. Recklessness on school grounds which may endanger other learners or lead to property damage.
- k. Possession of tobacco products, alcohol, or prohibited substances.
- I. Fighting, assault, theft, vandalism, or sexual abuse.
- m. Possession of pornography or any other such sexually explicit or inappropriate material.
- n. Committing a violation of the law of the Country.

Consequences of Schedule 1 violations:

Under normal circumstances, schedule 1 offences are dealt with in the classroom by the subject teacher which, if not leading to a schedule 2 offence, should mark the end of the matter. The parents will be notified during routine parent-teacher visits so that any problems may be improved upon.


Consequences of Schedule 2 offences:

Considering the gravity of schedule 2 offences;

- The parent is immediately notified and the learner is retracted from the classroom at the point of such a violation.
- In the interest of prompt resolution, and least amount of time lost and learning lost for the learner, the parent and school disciplinary committee are required to discuss the offence(s) and appropriate action will then be decided upon (max 3days).

It must be realized by all, that any learner behaviour which can potentially lead to the compromise of safety of other learners or staff is of primary concern and will justify the immediate expulsion of the offending learner from the school property. Furthermore, offences which entail a violation of state law will entail the involvement of law enforcement officials.

The parent/guardian of a learner engaged in a schedule 2 property offense shall be held liable for the repair or replacement of any property damage or theft."



IMPORTANT Terms and Conditions: SCHOOL and PRIVATE BOARDING HOUSE (where applicable)

1. INTELLECTUAL PROPERTY

All learner assignments remain Gems Field Private School's intellectual property to be used for promotional and related activities, selected assignments will be kept anonymous.

A. I consent to having my child's picture/videographed posted and used on Gems Field Private School's and or GEMS' Private Boarding House's (in the case of learners in boarding) social media pages/groups, leaflets and other promotional materials.

2. INDEMNITY/RELEASE

- A. I hereby assume all of the risks of participating in any/all activities associated and organized by Gems Field Private School, their representatives and or GEMS' Private Boarding House's (in the case of learners in boarding), including by way of example and not limitation, any risks that may arise from normal school activities including and not limited to sports, social interaction with other learners and staff, learning and recreation; whether on or off school property.
- B. In the event of school trips/excursions tours or any school related travel as a parent you have granted permission and undertake fully to release the school and its representatives of any liability that may occur in the course of a trip (any loss, injuries or damage to the learner and said learner's property).
- C. Should you choose to have your child excused from the said scheduled tour, you will inform the school in writing no later than 1 month to the date of the trip.

3. FEES PAYMENTS:

- ALL MONTHLY FEES ARE PAYABLE ON OR BEFORE THE FOURTH (4) DAY OF EACH MONTH. including holidays.
- <u>ALL</u> other fees (registration, levis, books, tours/excursions, e.t.c.) are payable on or before the 4th of the month or as as agreed upon)
- Monthly tuition invoices are not issued; it is the parent's responsibility to ensure that the said tuition
 arrives on time or before the deadline of the fourth day of each consecutive month. Invoices/e-mail,
 letter communication or Group What's App updates are only issued in the case of extra curricular
 services and other functions set-up and agreed upon between the school and the parent where
 applicable.

The school adheres to a strict payment policy outlined as follows:

Overdue accounts:

- **Up to 3 Days overdue**, a 10% of the outstanding balance late payment charge is applied as well as a friendly reminder text/what's App message will be issued.
- **INVOLUNTARY LEARNER WITHDRAWAL**: 7 Days later: if no payment is received the child will be sent home and will only be accepted if the outstanding account is paid in full.

This action may appear harsh, however when a student's account is not paid and he/she is permitted to remain in the school, the other parents are in fact unfairly subsidizing that student's tuition.

<u>PLEASE NOTE</u>: The school will <u>ONLY</u> <u>ACCEPT</u> electronic bank payment/electronic funds transfer EFT or direct bank deposits.

- **4. VOLUNTARY LEARNER WITHDRAWAL:** Thirty days (30) of advanced notice is required. If there is no advanced notice given then the next month's invoice will be charged. For students whose annual fee has been paid in full or in three installments, please contact the Finance Office to receive the early withdrawal refund schedule.
- **5. REFUND POLICY:** If a learner pays more than the required monthly tuition charge in advance, such as a term or the school year, he/she is entitled to a refund of any tuition paid beyond the current month's tuition.

6. ACKNOWLEDGEMENT

- I accept the risks that are associated with my child when we/I decide to allow him/her to participate in educational, sports and tour activities.
- I indemnify and hold Gems Field Private School and their representatives harmless from any injuries, demands, or death that may be sustained by my child.
